A RESOLUTION DECLARING VALID, MUNICIPAL ORDINANCE NO. 2019-003, OF THE SANGGUNIANG BAYAN OF ALANGALANG, LEYTE.



ARTICLE I

Policy and Definition of Terms

Section 1. Title – This ordinance shall be known as the "Municipal Youth Development Office and Municipal Youth Development Council Ordinance of the Municipality of Alangalang, Leyte."

Section 2. Declaration of Policy – It is declared policy of the Municipality of Alangalang, Leyte to promote and protect the physical, moral, spiritual, intellectual and social well-being of the Youth, by inculcating to them patriotism and nationalism, and encourage their involvement in public and civic affairs.

Section 3. Definition of Terms – as used in this ordinance the following terms shall mean:

- 1. Commission Refers to the National Youth Commission created under RA No. 8044 otherwise as the Youth in Nation Building Act of 1995.
- 2. In-School-Youth Refers to the youth attending either formal schools or non-school-based educational program under institution recognized by the state.
- 3. Local Youth Development Plan Refers to the Municipal Youth Development Plan as initially drafted by the Sangguniang Kabataan Municipal Federation, finalized by the Municipal Youth Development Council and approved by the Local Sanggunian LYDP shall be anchored on the Philippine Youth Development Plan (PYDP) and Local Development Plans of the Municipality of Alangalang, Leyte.
- 4. Local Youth Development Office (LYDO) Refers to the office of the Local Government Unit (LGU) which will ensure Youth participation in the locality.
- 5. Non-Traditional-Media Refers to websites, short and multi-media messaging system, social media platform and other media considered traditional.
- 6. Philippine Youth Development Plan (PYDP) 2017-2022 Refers to the Comprehensive National Plan expressing the convergence efforts of the different youth-serving national agencies, civil society organizations and youth organizations designed to promote the general welfare development and empowerment of the youth, and preparation for their vital role in nation-building.
- 7. **Traditional Media** Refers to advertisement and announcements on bulletin boards, newspapers, magazine, tabloids, periodicals, radio, television, and other similar media.
- 8. Working Youth Refers to youth who are either employed, self-employed, self employed, under employed or belong to specific employable job seeking youth groups (such as graduate of tertiary or vocational schools, or those who are previously where employed and are actively looking for work) both in the formal and informal sectors of the society.
- 9. Youth Refers to the person whose ages range from fifteen (15) to thirty (30) years old as defined in RA No. 8044. For the purpose of targeting programming for the youth the age disaggregation shall be considered:

15-17 - child youth

18-24 – core youth

25-30 - adult youth

- 10. Youth Development Office (YDO) Refers to the designated or appointed staff in the Local Government Unit (LGU) who provides technical assistance to the Local Youth Development Council (DYDC) in the formulation of the Local Youth Development Plan (LYDP)
- 11. Youth Organization Refers to organization with members in good standing entirely composed of the youth, who ages range from fifteen (15) to thirty (30) years old with core advocacy that serves the youth, registered through the Youth Organization Registration Program (YORP) of National Youth Commission.
- 12. Youth-Serving Organization Refers to organizations with members in good standing whose principal program, project and activities are youth related and youth oriented, and whose composition are not limited to the youth, also registered through the Youth Organization Registration Program (YORP) of National Youth Commission.
- 13. Youth Organization Registration Program (YORP) Aims to ensure easier access to the program nationwide, and eliminate the distance barrier between youth organization and the NYC area Officers, to register organization should prepare and complete the following:
 - a. YORP Registration Form
 - b. Directory of Officer and Advisers
 - c. List of members in good standing
 - **d.** Copy of constitution and by laws, and
 - e. Certification, endorsement or resolution from the appropriate authority.
- **14. Youth with Specific Needs** Refers to youth marginalized by existing societal, namely:
 - a. Youth in Indigenous Cultural Communities
 - b. Youth with disabilities
 - c. Youth in situation of armed conflict
 - d. Victims of natural disaster and calamities
 - e. Youth offender
 - f. Delinquent youth
 - g. Street youth
 - h. Abuse exploited youth, and
 - i. Abandoned / neglected youth

ARTICLE II

THE MUNICIPAL YOUTH DEVELOPMENT OFFICE

Section 4. Municipal Youth Development Office – There shall be a Local Youth Development office which shall be headed by a Youth Development Officer with the rank of a least division chief. Such maybe put under the Office of the Local Chief Executive.

It shall be consisted of division and units for policy and planning administration and finance, and program and operation programs.

Section 5. Qualification of the Youth Development Officer – in addition to the requirements prescribed by the Civil Service Commission (CSC), the youth development officer shall;

- 1. Be preferable not more than thirty years of age at the time of her/his appointment
- 2. Be a good moral character
- **3.** Must have acquired experience in youth development affairs or involvement in youth or youth serving organization for at least (3) years; and
- **4.** He/she shall be appointed by the Local Chief Executive (LCE). but in no case is he or she be within the fourth (4th) Civil degree of consanguinity or affinity of the appointing authority.

Section 6. Other Personnel of the Municipal Youth Development Office – Upon the recommendation of the Municipal Youth Development Officer, the Municipality of Alangalang. Leyte, may provide additional staffing requirements in the Municipal Youth Development Office and shall be appointed by the LCE in whatever status deemed appropriate, and in accordance with Civil Service Rules and Regulations.

Section 7. Functions of the Municipal Youth Development Office – The Municipal Youth Development Office shall have the following functions.

1. Register and verify youth-serving organizations.

2. Provide Technical assistance to the Municipal YDC in the formulation of the LYDP.

3. Facilitate the election of the Municipal YDC representatives.

- 4. Serve as Secretariat to the Municipal YDC and as such, shall provide the necessary administrative, operational, staff and technical support to the Municipal YDC.
- 5. Conduct the mandatory and continuing training of SK Officials and Municipal YDC Members, in accordance with the programs jointly designed and implemented by the Commission and the DILG. The Municipal Youth Development Officer and/or his or her staff shall apply for accreditation from the Commission in order for them to conduct the mandatory and continuing training programs of SK officials and Municipal YDC Members.
- **6.** Provide technical, logistical and other support in the conduct of the mandatory and continuing training programs, and for such other programs of the Commission and DILG.
- 7. Coordinate with the Commission, with regard to the youth programs within their jurisdiction.
- **8.** Performs such other functions as maybe prescribed by law, or as the LCE, the DILG or the Commission may require.

Section 8. Municipal Youth Development Office Fund – A fund with an initial amount of One Million Pesos (Php1,000,000.00) is hereby established and appropriated from any available source to be managed by the Municipal Youth Development Office. Thereafter, such amount needed for this purpose shall be included in the annual budget of the Municipality of Alangalang, Leyte.

ARTICLE III

MUNICIPAL YOUTH DEVELOPMENT COUNCIL

Section 9. Municipal Youth Development Council – To ensure wide and multi – sectoral youth participation in local governance, there shall be created a Municipal Youth Development Council. The Municipal YDC shall be headed by the SK Municipal Federation President and composed of representative of youth and youth-serving organizations in the Municipal level. The Municipal YDC shall assist the planning and execution of projects and programs of the SK and the Federation.

Section 10. Formal Organization of Non – Organization Youth – To give equal opportunity for the youth, from the time of the enactment of this ordinance up to the deadline for registration set by the Commission and DILG, non – organized youth groups may formally organize themselves and register in accordance with Section 12 and 13 of this Ordinance.

Section 11. Composition of Youth Organization and Youth Serving Organization – Youth organization is an organization with members entirely composed of the youth, whose ages ranges from fifteen (15) to thirty (30) years old with a core advocacy that serves the youth. On the other hand, youth serving organization is an organization with the same core advocacy whose members are not entirely composed of the youth which may include Civil Society Organizations, such as, but not limited to people's organizations and non-government organizations.

Section 12. Local Verification of Youth Organization and Youth Serving Organization – All organization and youth serving organization, with a minimum number of ten (10) numbers in good standing and which are operating in the Municipality shall register with the Municipal Youth Development Office.

Youth and youth serving organization who registered in other National Government Agencies shall also be recognized as registered organizations by the Municipal YDO. Provided, that the organization is based and or operates in the Municipality.

Section 13. Local Qualification of Organization and Youth Serving

Organization – The Municipal YDO shall verify the registration information provide by this organization. The Municipal YDO shall send a list of registered and verified youth organizations and youth organizations to the Commission.

Section 14. Renewal, Verification and Continuing Local Registration – Registered youth and youth-serving organizations shall renew their local registration and verification every three years. The Municipal YDO shall conduct a continuing registration procedure taking into consideration the budgetary and man power requirements and the presence of youth-serving organization.

Section 15. Condition Precedent – Local registration and verification of youth organization and youth serving organization is a condition precedent for participation in the Municipal YDC election.

Section 16. Qualification of the Members of the Municipal YDC – A Member of the Municipal YDC must be a citizen of the Philippines, a resident of the Municipality for not less one year immediately preceding the day of his/her election to the Municipal YDC. She/he should be eighteen (18) years, but not more than thirty (30) years of age on the day of his/her election at

the council, able to read and write Filipino, English or the local dialect, and must not have been convicted by final judgement of any crime involving moral turpitude.

Section 17. Composition of the Municipal YDC – The Municipal YDC shall be composed of at least ten (10) but not more than Twenty-one (21) members including the two (2) core members which shall be composed of the President and the Vice-President of the Pambayan na Pederasyon and shall be supported by at least eight (8) but not more than nineteen (19) other representative from registered youth oraganizations, or youth serving oraganizations. Provided, that all other incumbent SK officials shall not be eligible as members of the Municipal YDC.




The following advocacies shall be represented:

- 1. Education
- 2. Employment
- 3. Health
- 4. Participation and others as identified by the Municipal YDC

The following sectors shall also be represented:

- 1. In-School-Youth
- 2. Out-of-School-Youth
- 3. Working Youth
- 4. Youth with specific needs

Provided, if there is a need arises, representatives from national government agencies may be invited as resource person.



Section 19. Convening of the Municipal YDC – The duly elected President or Vice-President of the Pambayang Pederasyon ng mga SK shall automatically become members of the Municipal YDC. If the SK Federation President of the SK Federation fails to convene the Municipal YDC as scheduled, at least one-third of the total membership of the Municipal YDC, may call for a meeting. In both instances a written notice shall be sent, either through traditional or non-traditional means, to all members setting the date, time, place and agenda of the meeting which must be received at least two (2) days in advance. The presence of the majority of all members of the Municipal YDC shall constitute a quorum.

Section 20. Duties and Functions of the Municipal Youth Development Council (MYDC). The Municipal YDC shall discharge the following duties and functions:

- 1. Serve as the core advocacy on youth participation in nation-building and youth empowerment;
- 2. Finalize the three (3) years LYDP that is anchored in the PYDP and the development plans of the Municipality of Alangalang, Leyte.
- **3.** Monitor and evaluate the implementation of the Local Youth Development Plan; and
- 4. Perform such other functions as may be prescribed by law or ordinance.

The LYDP shall be initially be drafted by the SK Federation and shall be finalized by the Municipal YDC. This shall be submitted to the LCE for inclusion in the Local Development Plan and subsequently endorsed to the Sangguniang Bayan for approval. These plans are priority programs, projects, and activities (PPA's), that will promote and ensure the meaningful youth participation in nation-building sustainable youth development, environmental protection, climate change adaptation, disaster risk reduction and resiliency, youth development and livelihood, health and anti-drug abuse, gender sensitivity, social protection, capability building, and sports development.

Section 21. Municipal Youth Development Council Fund – A fund with an initial amount of One Million Pesos (Php 1,000,000.00), is hereby established and appropriated from any available source to be managed by the Municipal Youth Development Office. Thereafter, such amount needed for this purpose shall be included in the annual budget of the Municipality of Alangalang, Leyte.



FINAL PROVISIONS

Section 22 – Separability Clause – If for any reason, any section or provision of this Ordinance shall to be unconstitutional or invalid as declared by competent authority, such judgment or action shall not affect or impair the other sections or provisions thereof.

Section 23 – Repealing Clause – All ordinances, rules and regulations, or parthereof in conflict with any provisions of this Ordinance is hereby repealed or modified accordingly.

Section 24 - Effectivity - This Ordinance shall take effect upon its approval.
