

WHEREAS, in the light of Education, the schools in the Municipality of Alangalang has an uncontrollable increase of dropouts, called as Pupils/Students at Risk of Dropping Out due to family economic struggle;

WHEREAS, Article 26 of the Universal Declaration of Human Rights states that everyone has a right to education and that "Education shall be directed to the full development of the human personality and to the strengthening of respect for human rights and fundamental freedoms;

WHEREAS, the right to Education of a child as stated in the 1987 Constitution of the Republic of the Philippines, Article XIV, Sec. 1 provides that; "The State shall protect and promote the right of all citizens to quality education at all levels, and shall take appropriate steps to make such education accessible to all.";

WHEREAS, the municipality sees it fit to enact this measure in order to ensure the education sustainability of pupils/ students of the Municipality of Alangalang;

Be it ordained by the Sangguniang Bayan of Alangalang, Leyte that:

SECTION 1. Title- This Ordinance shall be entitled: "**AN ORDINANCE INSTITUTIONALIZING THE LIBRENG SAKAY PROGRAM FOR THE PUPILS AND STUDENTS IN THE MUNICIPALITY OF ALANGALANG AND APPROPRIATING FUNDS THEREOF**".

SECTION 2. SCOPE – This shall cover the selected and deserving Pupils and Students of the Municipality of Alangalang that requires them to be transported from their respective residences to schools. Along herewith are the selected hired Habal-Habal (Motorbike) and Side Car drivers that will take charge in the fetching.

SECTION 3. PURPOSE – of this Ordinance is to ensure the education sustainability of pupils/students of the Municipality of Alangalang.

SECTION 4. DEFINITION OF TERMS:

Libreng Sakay Program – This Ordinance shall also be known as Libreng Sakay Program.

Validator/Facilitator – MSWD as the Implementing Agency or Local Functionary

Pupils/Students – Residents of Alangalang shall be the Beneficiaries that must enrolled in the school within the Municipality of Alangalang that requires them to be transported from the residence to school through a Motorbike (Habal-Habal) or Motor Cycle for Hire (MCH).

Habal-Habal/MCH Drivers – Selected Resident of each respective barangay of Alangalang shall benefit on this program as responsible in transporting the pupils/students to and from their residence.

Section 5. INSTITUTIONALIZING AND SELECTION PROCESS. The MSWDO shall take charge of the selection of the pupils and/or students and the transportation on coordination with the Barangay Council.

5.1 Criteria of selection for pupil and/or student:

- a. Must be a resident of the municipality of Alangalang, Leyte;
- b. Must be currently enrolled in a school operating within the territorial jurisdiction of the municipality of Alangalang, Leyte; if the student is enrolled outside the jurisdiction of the municipality of Alangalang (nearest school), it shall be subject for assessment and validation and to be approved by the Local Chief Executive (e.g. Tabangohay Students enrolled at Paglaum High School, Tacloban City).
- c. Must be certified as indigent by the Punong Barangay as attested to by the validator or in the absence of the latter by the MSWDO.
- d. For must be a person (for minors) allowed by law to back ride in a single motorcycle.

5.2 Criteria of Selection for transportation:

- a. The driver must be a resident of the municipality of Alangalang, Leyte
- b. Must have a valid driver's license and registered single motorcycle; (this would require the issuance of a special permit which is incorporated in this ordinance
 - i. For single motorcycle
 1. Must be registered and must secure a special permit to enrol in this program
 2. Must have the basic safety gear such as but not limited to the provision of helmet to its passenger/s
 - ii. For MCH, the operator must have an existing franchise or permit to operate.

SECTION 6: SPECIAL PERMIT – After compliance of all the minimum requirements, a single motorcycle may be issued a special permit to operate as MC taxis in order to participate in the *Libreng Sakay Program* of this municipality, which shall be issued by the Local Chief Executive; provided that, all terms and conditions for safety shall be incorporated in the MOU OR MOA which shall be executed in relation to the program.

Example of the terms and conditions for safety (Single MC Taxis) which may be incorporated in the MOA/MOU.

- a. Must only operate in relation to program and under a determined route allowed by the municipality
- b. Maximum passengers shall only be 2 pupils or students whose height and age passed in minimum requirements for back riders
- c. Must wear and provide helmets to the passengers when transporting the latter from home and to the destination school and vise versa.

SECTION 7. APPROPRIATION – minimum of **Five Hundred Thousand Pesos (P500,000.00)** shall be allocated from the General Fund of the Municipality of Alangalang.

SECTION 8. REPEALING CLAUSE. All ordinances, resolutions, rules or regulations inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 9. SEPARABILITY CLAUSE- Should any of these clauses or parts of this Ordinance be declared unconstitutional by any court of competent jurisdiction, all other remaining portions not so declared shall remain valid and effective.

SECTION 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon its approval.


