



NOW THEREFORE, on motion of SB Member Kenneth Spice De Veyra duly seconded en masse by all Sangguniang Bayan Members present, be it-

BE IT ORDAINED as it is hereby ordained by the Sangguniang Bayan of Alangalang, in session duly assembled, THAT:

#### Section 1. Use of Savings and Augmentation.

In accordance with Section 336 of Republic Act No. 7160, the Local Government Code of 1991, the Mayor and/or the Presiding Officer of the Sanggunian is/are authorized to augment any item in the approved budget for their respective offices from savings in other within the same expense class of their respective appropriations.


For this purpose, "savings" refers to portions or balances of any programmed appropriation free from any obligation or encumbrance, still available after the satisfactory completion or the unavoidable discominuance or abandonment for the work, activity or purpose for which the appropriation is authorized, or arising from unpaid compensation and related costs pertaining to vacant positions and leaves of absence without pay.

"Augmentation" implies the existence in the budget of an item, project, activity or purpose with an appropriation which, upon implementation or subsequent of needed resources, is determined to be deficient.

Priority shall be given to the personnel benefits of local employees in the use of Personal Services Savings.

#### Section 3. REPEALING CLAUSE.

All Ordinances, executive orders, issuances including rules and regulations inconsistent with this ordinance are hereby repealed and/or modified accordingly.

#### Section 4. SEPARABILITY CLAUSE.

If any provision of this ordinance is declared invalid, the remainder or any provision herein not affected thereby shall remain in force and effect.

Section 5. EFFECTIVITY. This ordinance shall take effect upon approval ENACTED, by the Sangguniang Bayan on February 19, 2024.
