APPROVED on 3<sup>rd</sup> and final reading on May 20, 2024

On motion of SB Member Claire G. Yu duly seconded by SB Members Sarah T. Apurillo, Gina Balderamos and Ketchie Rex A. Barrantes.

WHEREAS, Presidential Proclamation No.33 on March 21, 1989 Declares the Month of May of every year as Farmers and Fishier folk month in the Philippines;

WHEREAS, the government of the Philippines has accorded the highest priority to the Development of Agriculture and Fishery not only to achieve an equitable distribution of benefits but also to enable the farmers maximize their contribution to the nation's health;

WHEREAS, the Municipality of Alangalang is an Agricultural producing area in which its vision is "The premier Agro-industrial, people centred Municipality by 2030";

WHEREAS, a total of 7,379.0589 hectares of farmland suitable for rice, corn, coco and high valued crops are being cultivated by a total of 4,569 farmers as the main source of subsistence livelihood;



**WHEREAS**, a Farmer's Day Celebration should be properly calendared each year for the purpose of giving recognition to the farmers for their important role and insurmountable effort that ensure the optimum, balance and sustainable Agricultural Development of Alangalang, Leyte;

**WHEREAS**, the Local Government Unit of Alangalang recognizes the role of the farmers sector in the upliftment of Agriculture;

**WHEREAS**, there is a need to strengthen the marketing matching, promotion and patronization of the locally produced product of farmers and fisher folk an income enhancement.

**NOW THEREOF**, be it ordained by the members of the Sangguniang Bayan in session duly assembled to enact:

**Section 1: Title** This Ordinance shall be known as 'Alangalang Farmer's Day Celebration.'

**Section 2: Declaration of Policy.** The Local Government of Alangalang, Leyte adheres to the principles of sustainable development and promotes self – sufficiency in crops and other prime commodities.

**Section 3: Scope and Coverage.** This Ordinance shall apply to persons engage in farming within the territorial jurisdiction of the Municipality of Alangalang, Leyte.

**Section 4: Definition of terms.** The words and phrases used in this code shall mean as follows:

1. Agriculture – the science, art or practice of cultivating the soil, producer's crops and raising livestock and in varying degrees the preparations and marketing of the resulting products.
2. Farmers – ( also called Agriculture), a person engaged in agriculture, raising living organism for food or raw materials the term usually applied to people who do some combination of raising field crops, orchards, vineyards, poultry and other livestock.
3. Incentives – something that tends to incite actions or greater effort as a regard for the increased productivity.

**Section 5: Program activity and incentives,** "The Farmer's Day" shall have several programs and activities for the whole day celebration which include, but not limited to the following:

- a.) Showcasing/Marketing of farm produce especially those organically and locally grown, hence, there should be no fees or market charges collected as incentives to farmers during the conduct of Agri – business trade/harvest and farm festival.
- b.) Farmers form and achievement day.
- c.) Annual search for the most outstanding farmer GINOO AND GINANG MAGSASAKA.

- d) Free Medical Diagnostic Examination to be provided by the Municipal Health Office to all registered farmers in the Municipality, certified by the Municipal Agriculture Office.
- e.) Search for Garden sa Bakuran.
- f.) Gabi ng MAGSASAKA

**Section 6: Funding and Appropriations** The funding and appropriations for the Farmers Week Celebration shall be source from the General Fund of the Local Government Unit.

**Section 7: Responsibility of the Municipal Agriculture Office** The formulation of the implementing rules, guidelines and produces necessary for the implementation of the plans, programs activities and other related matters pertaining to the yearly celebration of the Alangalang Farmers Week should be the primary responsibility of the Municipal Agriculture Office.

**Section 8: Separability Clause.** Ordinances, executive orders and other local legislations inconsistent with this ordinance are hereby modified or repealed accordingly.

**Section 7 : Repealing Clause.** All ordinance, local issuances or rules inconsistent with the provision of this Ordinance are hereby repealed or modified accordingly.

**Section 9: Effectivity** This ordinance shall take effect immediately upon its approval and in accordance with the provisions of the Local Government Code.



**A RESOLUTION APPROVING ORDINANCE NO. 2024-04 OF ALANGALANG, LEYTE.**

**WHEREAS**, pursuant to Section 468 (a)(1)(i) of Republic Act 7160 otherwise known as The Local Government Code of 1991, among the powers and duties of the Sangguniang Panlalawigan is "to review all ordinances approved by the Sanggunian of component cities and municipalities;"

**WHEREAS**, submitted to the Sangguniang Panlalawigan is **Municipal Ordinance No. 2024-04 of Alangalang, Leyte** entitled: **"AN ORDINANCE DECLARING THE 1<sup>ST</sup> WEEK OF JUNE OF EVERY YEAR AS FARMER'S WEEK CELEBRATION IN THE MUNICIPALITY OF ALANGALANG AND PROVIDING FUNDS THEREOF"**, for approval;


