

**“AN ORDINANCE CREATING THE PLANTILLA POSITION WITH THE TITLE COMPUTER FILE LIBRARIAN II IN THE LOCAL GOVERNMENT UNIT OF ALANGALANG, LEYTE.”**

Approved on 3<sup>rd</sup> and Final reading in motion of SB Members Hon. Ketchie Rex A. Barrantes seconded by Hon. Kent Jefflord C. Guillermo and Hon. Sarah T. Apurillo.

**EXPLANATORY NOTE:**

Because of the abolition of the previous Plantilla position Librarian I, (Salary Grade 10), and in line with the Scrap and Build process, this is ordinance in pursuit of proper alignment of item position, an item for Plantilla Position shall be created with the Title, Computer File Librarian II.

Be it ordained by the Sangguniang Byan in session that:

**SECTION 1.** The Plantilla position of Computer File Librarian II with Salary Grade 10 is hereby created in the Plantilla of positions in the Local Government Unit of Alangalang.

**SECTION 2.** Copies of this Ordinance be furnished for information and guidance.


**SECTION 3. SEPARABILITY CLAUSE.** If any provision of this ordinance is declared invalid, the remainder or any provision herein not affected thereby shall remain in force and effect.

**SECTION 4. REPEALING CLAUSE.** All Ordinances, executive orders, issuances including rules and regulations inconsistent with this ordinance are hereby repealed and/or modified accordingly.


**SECTION 5. EFFECTIVITY.** This ordinance shall take effect upon approval.



**RESOLUTION NO. 2024-363**

A RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2024-06 OF ALANGALANG, LEYTE, MUNICIPAL ORDINANCE NO. 2024-02 SERIES OF 2024 OF SAN MIGUEL, LEYTE, MUNICIPAL ORDINANCE NOS. 2024-07, 2024-08 AND 2024-10 OF TANAUAN, LEYTE.

**WHEREAS**, pursuant to Section 468 (a)(1)(i) of Republic Act 7160 otherwise known as The Local Government Code of 1991, among the powers and duties of the Sangguniang Panlalawigan is "to review all ordinances approved by the Sanggunian of component cities and municipalities;"

**WHEREAS**, submitted to the Sangguniang Panlalawigan are Ordinances from the different Municipalities of the Province of Leyte for approval, to wit:

- 2. Municipal Ordinance No. 2024-02 Series 2024 of San Miguel, Leyte** entitled: "SAN MIGUEL COMPREHENSIVE NUTRITION PROGRAM OF THE MUNICIPALITY OF SAN MIGUEL, LEYTE";
- 3. Ordinance No. 2024-07 of Tanauan, Leyte** entitled: "AN ORDINANCE ENACTING THE INSTALLATION OF BEHAVIORAL NUDGES IN PRIORITY SETTINGS FOR THE MUNICIPALITY OF TANAUAN, LEYTE";
- 4. Ordinance No. 2024-08 of Tanauan, Leyte** entitled: "AN ORDINANCE INSTITUTIONALIZING INCLUSIVE EDUCATION AND ESTABLISHING AN INCLUSIVE LEARNING RESOURCE CENTER OF ALL LEARNERS WITH DISABILITIES IN THE MUNICIPALITY OF TANAUAN, LEYTE AND PROVIDING FUNDS THEREFOR";

5. **Ordinance No. 2024-10 of Tanauan, Leyte** entitled: “**AN ORDINANCE CREATING THE POSITION OF EIGHT (8) (CLERK I) CASUAL AND FOUR (4) ADMINISTRATIVE AIDES (CASUAL) WITH SALARY GRADE SG 3 AND SG 1, RESPECTIVELY AND PROVIDING FUNDS THEREFORE**”;

**WHEREAS**, the Provincial Legal Office was requested to review and submit recommendation on the subject Ordinances pursuant to Section 481 (3) (vii) of R.A. 7160;

**WHEREAS**, the Provincial Legal Office through Atty. Jose Raymund A. Acol, Assistant Provincial Legal Officer, recommended for the declaration of its validity of the subject ordinances, to wit:

1. **Municipal Ordinance No. 2024-06 Series of 2024 of Alangalang, Leyte**, as it is within the corporate powers of the local government unit particularly covered under Section 447 (viii) and Section 76 of the Local Government Code of 1991;
2. **Municipal Ordinance No. 2024-02 Series of 2024 of San Miguel, Leyte**, as it is in accordance to its power under Section 16, 17 (a) and Section 447 of the Local Government Code, likewise, said ordinance is pursuant to Article II, Section 15 and Article XV, Section 3 of the 1987 Constitution;
3. **Ordinance No. 2024-07 of Tanauan, Leyte**, as it is within the powers provided under Section 16 of the Local Government Code of 1991 (R.A. 7160);
4. **Ordinance No. 2024-08 of Tanauan, Leyte**, as it is within the powers covered under Section 16 General Welfare Clause of the Local Government Code of 1991 (R.A. 7160);
5. **Ordinance No. 2024-10 of Tanauan, Leyte**, as it is within the powers provided under Section 447 (I) (viii) of the Local Government Code of 1991 (R.A. 7160);

**WHEREAS**, the August Body, upon review, finds the subject Ordinances in conformity with the existing laws, rules and regulations;


