RESOLUTION NO. 2023-498

A RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 17 SERIES 2023 OF ALANGALANG, LEYTE.

WHEREAS, pursuant to Section 468 (a)(1)(i) of Republic Act 7160 otherwise known as The Local Government Code of 1991, among the powers and duties of the Sangguniang Panlalawigan is "to review all ordinances approved by the Sanggunian of component cities and municipalities;"

WHEREAS, submitted to the Sangguniang Panlalawigan is **Municipal Ordinance No. 2023-17 of Alangalang, Leyte** entitled: "**AN ORDINANCE CHANGING THE POSITION TITLE OF BOARD SECRETARY V TO MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (SECRETARY TO THE SANGGUNIAN) SG24 TO CONFORM WITH THE PROVISION IN ARTICLE ONE, TITLE FIVE OF R.A. 7160**", for approval;
