#### Be it ORDAINED by the Sangguniang Bayan in session assembled:

WHEREAS, the Local Government Unit shall establish adequate, effective and enabling mechanism and support systems that will ensure the meaningful participation of the youth in local governance and nation building;

whereas, the State recognizes the vital role of the youth in nation-building. Towards this end, the State declares as its policy the protection of the youth's physical, moral, spiritual, intellectual and social well-being. It further aims to inculcate in them patriotism and nationalism as well as encourage involvement in public and civic affairs.

- WHEREAS, through the Linggo ng Kabataan, the youth is given a venue that gives due importance to the development of an active and empowered youth sector.
- WHEREAS, Republic Act No. 8044 states that the "youth" is the critical period in a person's growth and development from the onset of adolescence towards the peak of maturity, self-reliant and responsible adulthood compromising the considerable sector of the population from the age of fifteen (15) to thirty (30) years;
- WHEREAS, with the fact that the youth has the highest population, they are considered as the most important assets of the government, if harnessed to their maximum potential. Thus, the youth'[s participation state affairs, especially those which relate to their interests cannot be overemphasized. The challenge then to the government is how to mobilize effectively this large youth population to help in the social, economic, and cultural development of our country.
- WHEREAS, in Section 23, Chapter III of Republic Act 10742 or the SK Reform Act of 2015 states that to ensure wide and multi-sectoral youth participation in local governance, there shall be a Municipal Youth Development Council [MYDC] in the municipality.
- WHEREAS, Ordinance No. 2021-02 recognizes the role of the youth in nation-building and the creation of Local Youth Development Council.
- whereas, in Section 24[b], Rule III of the Implementing Rules and Regulations [IRR] of RA 10742 states that "to give equal opportunity for the youth, from the time of the enactment of these rules up to the deadline for registration set by the National Youth Commission and DILG, non-organized youth groups may formally organize themselves and register in accordance with paragraphs d and e of this Section."
- WHEREAS, Sec.30, Chapter VI of RA 10742 otherwise known as the SK Reform Act of 2015 provides that every local government unit shall conduct an annual activity to be known as "The Linggo ng Kabataan" on the week where the 12th of August falls to coincide with the International Youth Day.
- WHEREAS, there is a need for a Local Youth Development Council that will afford protection and promote the welfare of the Alangalang Youth that will help them realize their vital role in nation building.
- NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Alangalang, that:
- Section 1. TITLE. This Ordinance shall be known as the Lovely Youth Week Ordinance of 2023
- Section 2. DECLARATION OF POLICY. Pursuant to Article II, Section 13 of the Philippines Constitution, the State recognizes the vital role of the Youth in nation-building. It shall promote and protect their physical, moral spiritual, intellectual and social well-being, inculcate in their patriotism and nationalism and encourage their environment in public and civic affairs, thus, under Sec.30, Chapter VI of RA 10742 otherwise known as the SK Reform Act of 2015 provides that every local government unit shall conduct an annual activity to be known as "The Linggo ng Kabataan" on the week where the 12th of August falls to coincide with the International Youth Day.

#### Section 3. GENERAL OBJECTIVES.

Section 4. DEFINITION OF TERMS. For purposes of this Ordinance, these are defined as follows:

- Youth refers to those persons whose age ranges from fifteen (15) to thirty (30)
   Years as provided under Republic Act No. 8044.
- Council refers to the Local Youth Development Council as provided herein.
- Center refers to a multi-purpose or one-stop-shop facility as any is established by the local youth coordinating council that shall provide development program and service to the youth.
- 4. **Development** the improved well-being, or welfare, of people and the process by which this is achieved, the sustained capacity to achieve a better life;
- Municipal Local Government Operations Officer (MLGOO)- shall refer to the duly designated head of the office of the DILG stationed in the concerned local government unit;
- 6. Local Sanggunian- shall refer to the sangguniang bayan;
- Local Youth Development Office (LYDO)- refers to the office established in Local Government Unit (LGU) by virtue of Chapter V, Section 25 of Republic Act No. 10742.
- Youth Development Officer- refers to the LGU personnel duly appointed or designated by the Local Chief Executive to head the Local Youth Development Office (LYDO);
- Local Youth Development Council (LYDC) A multi-sectoral youth association, which shall be called, Municipal Youth Development Council (MYDC), respectively, headed by the concerned SK Federation President and composed of representatives of youth and youth-serving organizations in the municipal level;
- 10. Local Youth Development Plan (LYDP) shall refer to the provincial, city, or municipal youth development plan as initially drafted by the SK Pederasyon, finalized by the LYDC and approved by the local sanggunian. Local Youth Development Plan (LYDP) shall be anchored on the Philippine Youth (PYDP) and the local development plans of the local government unit concerned;
- 11. Philippine Youth Development Plan (PYDP) shall refer to the comprehensive national plan expressing the convergence efforts of the different youth-serving national agencies, civil society organizations and youth organizations designed to promote the general welfare, development and empowerment of the youth, in preparation for their vital role in nation-building. The formulation of the plan shall be spearheaded by the Commission, and shall be based on the findings of the National Youth Assessment Study, Youth Development Index, and the directions set by the Philippine Development Plan. It may also take into consideration the findings of the different international organizations;
- 12. Local Chief Executive (LCE)- shall refer to the municipal mayor;
- Youth Organizations shall refer to those organizations whose membership or composition are youth;
- 14. Youth-Serving Organizations shall refer to those registered organizations whose principal programs, projects and activities are youth-oriented and youth-related, and whose compositions are not limited to the youth. The organization shall be duly-recognized or accredited either by proper national or local government registering entities.

- 15. Sangguniang Kabataan (SK)- is a council meant to represent the youth in each barangay in the Philippines.
- 16. Municipal Youth Development Council (MYDC)- is the existing LYDC and the highest youth council in the municipality.
- Section 5. PROGRAMS AND ACTIVITIES- the youth of the Municipality of Alangalang are encouraged to participate in the Linggo ng Kabataan activities, Municipal Youth Month activities, and Municipal Youth Day activities. These activities shall focus on the youth of the municipality of Alangalang to unify their actions towards the total development of the youth, to encourage them to participate in various programs of the youth in government and to empower them, and to provide them venue for actual public service. During the celebration of the Municipal Youth Month and Youth Day, various programs and activities will be conducted for the youth, such as the following:
  - On the Spot Logo/Slogan/Poster Making Contest An enhancement activity
    for the youth's artistic expression of patriotism, nationalism and social issues.
    This activity is primarily directed towards the development and improvement of
    arts and culture.
  - Alangalang Henyo An intellectual exercise for the youth of the Municipality of Bacolor which aims to develop love of country and nationalism and enhance their awareness of the history of Alangalang, Leyte
  - 3. LNK Festival The LNK Festival aims for the youth's appreciation in local culture and the arts. This is in line with nurturing the youth's creativity, artistry and unlock different talents through culture and the arts.
  - 4. Community Service Activity/Clean Up Drive/Tree Planting This shall be a week-long program whereby the youth through their respective SK Chairperson conduct pre-planned activities that enable them to concretize their own objectives. Activities such as, clean and green, visiting and sharing for indigents, Person with Disabilities(PWD), orphans, prisoners and disadvantaged groups and free medical mission aim to promote their sense of social commitment, social responsibility and civic-mindedness and the likes.
  - 5. Leadership Training and Other Skills Development Workshops/Leaders Conference - As future leaders and caretaker of the country, training programs and workshops are to be conducted to develop their leadership skills and develop necessary knowledge, attitude and values.
  - 6. Awarding for the Outstanding Sangguniang Kabataan, Outstanding Youth Alangalanganon - A culminating day to award outstanding SK, youth in the academe, government, sports and arts. Other Organizations and institutions which are supportive of vital youth issues concerns ' shall also be recognized. Plaques of Appreciation shall likewise be given by the Committee.
  - Laro ng Lahi Promotes physical health and develop skills among youth, build strong camaraderie and sportsmanship.
  - Song Composition Using the Waray Language Battle of the bands, singing competition showcasing the local dialect and talents of the youth in the Municipality of Alangalang.
  - 9. Such other projects and programs as maybe considered valuable to the total development of the youth.

Section 6. EXECUTIVE COMMITTEE. There shall be executive committee to lead and oversee the conduct of all programs and activities of the Municipal Youth Month and Youth Day Celebration in the Municipality of Alangalang which shall be composed of the following;

Local Chief Executive (LCE)

VICE CHAIRPERSON

Municipal SK Federation President (MSKFP)

Members

Local Youth Development Officer (LYDO)
Local Youth Development Council (LYDC)

Sangguniang Bayan Member- Vice

- Section 7. FUNCTION. The Executive Committee shall organize working committee to manage the implementation of the different component programs seek other committees necessary for the success of the activity. It shall require exact compliance with the rules and regulations, guidelines, and procedures it has promulgated, as recommended by the working committees.
- Section 8. COUNTERPART OF LOCAL AND NATIONAL AGENCIES. All local elective and appointive officials, as well as heads of National Agencies stationed or assigned in the territorial jurisdiction of the local government unit including barangay officials are enjoined to provide necessary coordinative and logistic support to ensure the success of the program.
- Section 9. FUNDS. The required funds needed for the implementation of the Linggo ng Kabataan shall be duly allocated as determined by the Executive Committee and subject to the usual accounting and auditing procedures in the disbursement of funds, thus, at the barangay level, pursuant to R.A 10742, the celebration of Youth Day and Youth Month should be from the 10% SK Fund of the barangay with no fixed percentage depending on the allocated budget of each barangays.
- Section 10. FAILURE TO OBSERVE THE PROVISION OF THE ORDINANCE SHALL DEAL THE PENALTIES IMPOSED UNDER R.A 10742.
- Section 11. APPLICABILITY CLAUSE. The provisions of existing ordinances dealing on the same subject matter which are not in conflict with, or contrary to the provisions of this Ordinance are hereby adopted and made an integral part of this Ordinance.
- Section 15. Separability Clause. If for any reason or reasons, any part or any provision hereof shall be held to be constitutional or invalid, other parts or provisions hereof which are not affected hereby shall continue to be in full force and effect.
- Section 16. Repealing Clause. All ordinances, resolutions or laws of local application and effect inconsistent hereto are hereby modified, suspended and modified accordingly, Municipal Ordinance No. 18 are specifically repealed by this ordinance.

ection 17. Effectivity. This ordinance shall take effect fifteen days (15) after publication in newspaper of local circulation.
