APPROVED on 3rd and final reading on JULY 22, 2024

ARTICLE I Title of the Proposed Ordinance

Title: The ordinance shall be known as the "Ordinance Providing Wage Increase for Job Order Personnel in the Municipality of Alangalang, Leyte."

ARTICLE II Coverage

WHEREAS, the Sangguniang Bayan enacted an Ordinance which increased the wages of job order employees in the Municipality of Alangalang from P300.00 per day to P405.00 per day effective January 2025;



Page 2- (Municipal Ordinance No. 2024-10) July 22, 2024

WHEREAS, prices of commodities, utilities, and other goods and services, as well as fare rate had increased a number of times since the last wage increase, thereby, weakening drastically the purchasing power of the P300.00 per day wage, and increasing the suffering of the families whose daily sustenance depends solely on the meager income of the concerned job order personnel;

WHEREAS, it is the intention of the Local Government and the Sangguniang Bayan to increase the daily wage of job order personnel employed by the Municipality of Alangalang.

NOW, THEREFORE, be it enacted by the Sangguniang Bayan in session assembled, that:

SECTION 1. Title. This Ordinance shall be known as ORDINANCE PROVIDING WAGE INCREASE FOR JOB ORDER PERSONNEL IN THE MUNICIPALITY OF ALANGALANG, LEYTE.

SECTION 2. Wage Increase. The current P300.00 per day rate as job order personnel is hereby increased to P405.00 per day effective January 2025.

SECTION 3. Separability Clause. If any provisions of this ordinance is declared invalid, the remainder or any provision herein not affected thereby shall remain in force and effect.

SECTION 4. Repealing Clause. All provisions of the municipal ordinance, orders or regulations inconsistent herewith, are hereby amended/modified/repealed accordingly.

SECTION 5. Effectivity. This Ordinance shall take effect upon its approval.


