

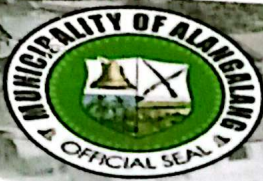

**"AN ORDINANCE GRANTING ONE-TIME DISCOUNT OF THE UNPAID OBLIGATION ON WATER BILLS OF WATER CONCESSIONAIRES OF THE ALANGALANG WATER SUPPLY SYSTEM (AWASS) OF THE MUNICIPALITY OF ALANGALANG, LEYTE."**

APPROVED on 3<sup>rd</sup> and final reading on SEPTEMBER 09, 2024

### SECTION 1. TITLE

*Title: The ordinance shall be known as the "An Ordinance Granting One Time Discount of the Unpaid Obligation on Water Bills of the Water Concessionaires of the Alangalang Water Supply System (AWASS) of the Municipality of Alangalang, Leyte."*

### SECTION 2. SCOPE.

This Ordinance shall govern the procedures of granting one-time discount to delinquent and current concessionaires.

### SECTION 3. DEFINITION OF TERMS:

As used in this Ordinance, the terms hereunder stipulated are defined as follows:

- A) **Current Concessionaires** - refers to the Alangalang Water Supply System's concessionaires who do not have water bill arrears;

- B) **Discount** - refers to the amount deducted to the total water bills upon full payment as indicated in Section 4 of this Ordinance;
- C) **Monthly Billing** - refers to the monthly water bill issued to the water concessionaires;
- D) **Residential Concessionaires** - refers to the concessionaires who utilize water supply from the Alangalang Water Supply System for domestic purposes only;
- E) **Institutional Concessionaires** - refers to the concessionaires who utilize water supply from the Alangalang Water Supply System for private and public schools, Barangay Hall, and all offices of the local or national government agencies' only;
- F) **Commercial Concessionaires** - refers to the concessionaires who utilize water supply from Alangalang Water Supply System for commercial purposes only;
- G) **Industrial Concessionaires** - refers to the concessionaires who utilize water supply from the Alangalang Water Supply System for commercial purposes only;
- H) **Water Concessionaire** - refers to the person authorized to use the Alangalang Water Supply System's water service upon compliance with the Water Service Application Requirements;
- I) **Water Supply System** - refers to the Level III Waterworks System of LGU Alangalang.

**SECTION 4. GRANTING OF DISCOUNT OF UNPAID OBLIGATION ON WATER BILLS:**



- 4.1. Residential/Industrial Concessionaires who shall pay his/her water bill arrears shall be granted a fifty percent (50%) discount if payment is made from October to December 2024;
- 4.2. Commercial/Industrial and Institutional Concessionaires who shall pay his/her water bill arrears from October to December 2024 shall be granted a fifty percent discount;
- 4.3. Current water concessionaires with no arrears shall be granted a one-time discount of fifty percent (50%) of their water bills from October to December 2024;
- 4.4. Failure to pay the water bill arrears until December 31, 2024, or until the last working day of the calendar year 2024, shall mean automatic water supply service disconnection beginning January 1, 2025.

**SECTION 5. SEPARABILITY CLAUSE** - If for any reason, any part or provision of this ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

**SECTION 6. REPEALING CLAUSE** - All ordinance, provisions, resolutions, executive orders, Memorandum circulars, administrative orders, and other issuances or parts thereof which are inconsistent with any provisions of this ordinance are hereby repealed or modified accordingly.

**SECTION 7. EFFECTIVITY CLAUSE.** This Ordinance shall take effect upon its approval.

**WHEREAS**, pursuant to Section 468 (a)(1)(i) of Republic Act 7160 otherwise known as The Local Government Code of 1991, among the powers and duties of the Sangguniang Panlalawigan is "to review all ordinances approved by the Sanggunian of component cities and municipalities;"

4. Ordinance No. 2024-17 of Tanauan, Leyte, entitled: "AN ORDINANCE CREATING THE POSITIONS OF OCCUPATIONAL THERAPIST II, SG 15; OCCUPATIONAL THERAPIST III, SG 18; AND SPEECH THERAPIST II, SG 14 IN THE MUNICIPAL GOVERNMENT OF TANAUAN, LEYTE AND PROVIDING FUNDS THEREFOR";

**5. Municipal Ordinance No. 2024-05 SERIES 2024 of San Miguel, Leyte** entitled: **“AN ORDINANCE ESTABLISHING AND OPERATIONALIZING THE BARANGAY HUMAN RIGHTS ACTION CENTER (BHRAC) IN EVERY BARANGAY IN THE MUNICIPALITY OF SAN MIGUEL, LEYTE, CAPACITATING THE BARANGAY HUMAN RIGHTS ACTION OFFICERS (BHRAO), AND PROVIDING FUNDS THEREFORE AND FOR OTHER PURPOSES”;**

**WHEREAS**, the Provincial Legal Office through Atty. Jose Raymund A. Acol, Assistant Provincial Legal Officer, recommended for the declaration of its validity of the subject ordinances, to wit:

- 1. Municipal Ordinance No. 2024-11 of Alangalang, Leyte**, is generally in accordance to its power under Section 447 (3)(i) of the Local Government Code of 1991 (R.A. 7160);
- 2. Ordinance No. 2024-15, 2024-16 and 2024-17 of Tanauan, Leyte**, are generally in accordance to its power under Section 447 (I)(viii) of the Local Government Code of 1991 (R.A. 7160) in consonance with Section 76;
- 3. Municipal Ordinance No. 2024-05 of San Miguel, Leyte**, is generally in accordance to its power under Section 447 of the Local Government Code of 1991 (R.A. 7160) in consonance with Section 447 (5)(xiv);

**WHEREAS**, the August Body, upon review, finds the subject Ordinances in conformity with the existing laws, rules and regulations;

**NOW, THEREFORE**, on omnibus motion presented by Atty. Ronnan Christian M. Reposar, duly seconded by Atty. Carlo P. Loreto, Honorable Ma. Corazon E. Remandaban, and Honorable Marie Kathryn Veloso - Kabigting, be it


