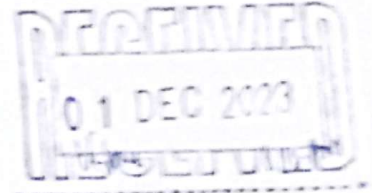



**APPROVED on 3<sup>rd</sup> and Final reading in motion of SB Member Ketchie Rex A. Barrantes duly seconded by SB Members Sheila Antoni-Rebato, Claire G. Yu, Gina Balderamos and Kent Jefflord C. Guillermo.**

Be it ENACTED by the Sangguniang Bayan in session assembled, that:

**Section 1. TITLE.** This Ordinance shall be known as, An Ordinance Renaming the Langit Elementary School to C. Galdo Elementary School of Brgy. Langit Alangalang, Leyte.

**Section 2. PURPOSE OF THE ENACTMENT.** This Ordinance is enacted in appreciation of the generosity of the Galdo Family and in recognition of their contribution to the education sector.

**Section 3. LEGAL BASIS.**

1. Section 13, Book I, Title I, Chapter II of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Bayan to change the name of the municipal public schools within its territorial jurisdiction upon recommendation of the Local School Board.
2. Resolution No. 11, series of 2023 of the Local School Board of Alangalang recommending the renaming of the Langit Elementary School to C. Galdo Elementary School.

**Section 4. DECLARATION OF POLICY.** It is hereby declared that Langit Elementary School be renamed as C. Galdo Elementary School in the Municipality of Alangalang, Province of Leyte.

**Section 5. REPEALING CLAUSE.** All Ordinances, executive orders, issuances including rules and regulations inconsistent with this ordinance are hereby repealed and/or in modified accordingly.

**Section 6. SEPARABILITY CLAUSE.** If provision of this ordinance is declared invalid, the remaining or any provision herein not affected thereby shall remain in force and effect.

**Section 7. EFFECTIVITY.** This Ordinance shall take effect upon approval.

**ENACTED**, by the Sangguniang Bayan on November 22, 2023.

**APPROVED**, by the Mayor on 11-30-2023.

RESOLUTION NO. 2023-567

A RESOLUTION APPROVING ORDINANCE NO. 440-A OF BABATNGON, LEYTE, MUNICIPAL ORDINANCE NOS. 18 AND 21 SERIES OF 2023 OF ALANGALANG, LEYTE.

**WHEREAS**, pursuant to Section 468 (a)(1)(i) of Republic Act 7160 otherwise known as The Local Government Code of 1991, among the powers and duties of the Sangguniang Panlalawigan is "to review all ordinances approved by the Sanggunian of component cities and municipalities;"

**WHEREAS**, submitted to the Sangguniang Panlalawigan are Ordinances from two municipalities of the Province of Leyte, for approval, to wit:

1. **Ordinance No. 440-A of Babatngon, Leyte** entitled: "AN ORDINANCE AMENDING SECTION 7 (Source of Funding) OF ORDINANCE NO. 440 OF BABATNGON, LEYTE ENTITLED: "AN ORDINANCE GRANTING CASH INCENTIVES FOR PASSERS AND TOPNOTCHERS (TOP 1 TO 10) OF BOARD, BAR AND OTHER NATIONAL LICENSURE EXAMINATION AND APPROPRIATING FUNDS RELATIVE THERETO";
2. **Municipal Ordinance No. 2023-18 of Alangalang, Leyte** entitled: "AN ORDINANCE DECLARING THE MONTH OF AUGUST AS MUNICIPAL YOUTH MONTH AND AUGUST 12 AS MUNICIPAL YOUTH DAY IN THE MUNICIPALITY OF ALANGALANG, LEYTE, ENJOINING ALL THE 54 BARANGAYS TO ACTIVELY PARTICIPATE IN ITS CELEBRATION AND PROVIDING FUNDS THEREFOR";
3. **Municipal Ordinance No. 2023-21 of Alangalang, Leyte** entitled: "AN ORDINANCE RENAMING THE LANGIT ELEMENTARY SCHOOL TO C. GALDO ELEMENTARY SCHOOL OF BARANGAY LANGIT, ALANGALANG, LEYTE";

**WHEREAS**, the Provincial Legal Office was requested to review and submit recommendation on the subject Ordinances pursuant to Section 481 (3) (vii) of R.A. 7160 with recommendation under Ordinance No. 2023-21 of Alangalang, Leyte that the Sangguniang Panlalawigan be furnished an original and signed copy of Resolution No. 11, Series of 2023 of the Local School Board for confirmation;
