SECTION 1. TITLE -This ordinance shall be known as the "Ordinance Institutionalizing the PINTAYO Competition of the Sangguniang Kabataan of Alangalang."

SECTION 2. DECLARATION OF POLICY -It is hereby declared the policy of the Sangguniang Kabataan (SK) of Alangalang to promote and institutionalize the PINTAYO Competition as a platform for showcasing the artistic talents, creativity, and cultural heritage of the youth in the locality. This competition aims to foster unity, camaraderie, and civic engagement among the youth through artistic expression.

SECTION 3. OBJECTIVES -The objectives of the PINTAYO Competition are as follows:

- a. To provide a venue for the youth to express their creativity through painting, drawing, and other visual arts.
- b. To promote and preserve the local cultural heritage through artistic endeavors.
- c. To enhance the sense of community and camaraderie among the youth of Alangalang.
- d. To encourage the active participation of the youth in cultural and artistic activities.


SECTION 4. MECHANISMS -The SK of Alangalang shall establish the following mechanisms for the PINTAYO Competition:

- a. **Development of Guidelines:** The SK shall develop clear and comprehensive guidelines for the conduct of the PINTAYO Competition, outlining criteria, eligibility, and evaluation processes.
- b. **Formation of Judging Panel:** A panel of qualified judges, including local artists and cultural advocates, shall be formed to objectively evaluate the entries based on the established criteria.
- c. **Promotion and Publicity:** The SK shall undertake promotional activities to encourage widespread participation and awareness of the PINTAYO Competition within the community.
- d. **Awarding Ceremony:** An awarding ceremony shall be organized to recognize and celebrate the winners of the PINTAYO Competition. Prizes and certificates of recognition shall be awarded to outstanding participants.

SECTION 5. ALLOCATION OF FUNDS -The Sangguniang Kabataan of Alangalang shall allocate necessary funds for the successful implementation of the PINTAYO Competition. These funds shall cover expenses related to prizes, materials, venue, and other logistical requirements.

SECTION 6. REPEALING CLAUSE – All Ordinance, executive orders, issuances including rules and regulations inconsistent with this ordinance are hereby repealed and/or in modified accordingly.


SECTION 7. SEPERABILITY CLAUSE – If provision of this ordinance is declared invalid, the remaining or any provision herein not affected thereby shall remain in force and effect.



SECTION 8. EFFECTIVITY This ordinance shall take effect fifteen (15) days after its approval.

RESOLUTION NO. 2024-132

A RESOLUTION APPROVING ORDINANCE NO. 457 OF BABATNGON, LEYTE; MUNICIPAL ORDINANCE NOS. 2023-21; 2023-22; 2023-23; AND 2024-01 SERIES OF 2024 OF ALANGALANG, LEYTE.

WHEREAS, pursuant to Section 468 (a)(1)(i) of Republic Act 7160 otherwise known as The Local Government Code of 1991, among the powers and duties of the Sangguniang Panlalawigan is "to review all ordinances approved by the Sanggunian of component cities and municipalities;"

WHEREAS, submitted to the Sangguniang Panlalawigan are Ordinances from Babatngon and Alangalang, Leyte, for approval, to wit:

4. Municipal Ord. No. 2023-23 of Alangalang, Leyte entitled: "AN ORDINANCE INSTITUTIONALIZING THE EXPANDED BENEFITS OF THE PANTAWID PAMILYANG PILIPINO PROGRAM (4Ps) BENEFICIARIES IN THE MUNICIPALITY OF ALANGALANG, LEYTE";
5. Municipal Ord. No. 2024-01 of Alangalang, Leyte entitled: "AN ORDINANCE AUTHORIZING THE MAYOR AND/OR THE PRESIDING OFFICER OF THE SANGGUNIAN TO USE SAVINGS FOR AUGMENTATION IN ACCORDANCE WITH THE LOCAL GOVERNMENT CODE OF 1991";

WHEREAS, the Provincial Legal Office through Atty. Jose Raymund A. Acol, Assistant Provincial Legal Officer, per attached indorsements, recommended for the declaration of validity on the subject Ordinances, to wit: on **Ordinance No. 457 of Babatngon, Leyte**, pursuant to the power under Section 17 (2) (iii) of the Local Government Code in relation to DOH AO No. 2019-0046; on **Municipal Ordinance No. 2023-21 of Alangalang, Leyte**, pursuant to the power under Section 426 (a), (b) and (c) of the Local Government Code; on **Municipal Ordinance No. 2023-22 of Alangalang, Leyte**, pursuant to the power under Section 22 (b) of the Local Government Code, provided that the logo be registered with the DILG, as provided; on **Municipal Ordinance No. 2023-23 of Alangalang, Leyte**, pursuant to the power under Section 16 of the Local Government Code, in relation to RA 11310; and **Municipal Ordinance No. 2024-01, Alangalang, Leyte**, pursuant to the power under Section 336 of the Local Government Code, provided that the augmented savings shall be within the same expense class of their respective appropriations;


WHEREAS, the August Body, upon review, finds the subject Ordinances in conformity with the existing laws, rules and regulations;
